With the approval of the Competent Authority, it has been decided to hold a Limited Internal Competitive Examination (LICE) for promotion to the Cadre of Telecom Technician (Erstwhile Telecom Mechanic) to be held on 08.09.2019 in order to fill up the vacancies for the vacancy upto 31-03-2019 as per the provision in the Recruitment Rule of Telecom Technician (Erstwhile Telecom Mechanic) circulated vide BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19.09.2012. The scheme and syllabus circulated vide BSNL Corporate Office Letter No. 250-74/2001-PERS-III(Part) dated 18<sup>th</sup> Oct 2011 shall be applicable for the same. **(Annexure-A & B)**.

The recruitment year of the LICE for Telecom Technician shall be 2018; 01-07-2018 shall be the crucial date for reckoning the eligibility of candidate for appearing in the LICE, as conveyed by BSNL CO L No. 250-2/2014-Est-III dtd. 22<sup>nd</sup> Feb, 2019.

3. The examination will be conducted through written mode and as per revised Scheme and syllabus of examination circulated vide BSNL CO L No. 250-74/2001-PERS-III(Part) dated 18<sup>th</sup> Oct 2011 (**Annexure-B**). The details of Papers and Time Table of the examination will be as under

- The level of examination shall be of 10<sup>th</sup> Standard.

4. There will be negative marking and for each wrong answer 25% of the mark of that question shall be deducted.

5. Minimum qualifying marks prescribed is 30% in each part and 37% in aggregate in respect of 'OC/OBC' candidates and 20% in each part and 30% in aggregate in respect of 'SC/ST' candidates.

6. The eligibility for appearing in the above mentioned Limited Departmental Competitive Examination shall be as per existing Recruitment Rules issued by BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19<sup>th</sup> Sep 2012 (**Annexure-A**).

7. The employees, who are eligible in accordance with the eligibility conditions as referred in the Recruitment Rules and who desire to appear in the examination should submit application offline/online to the **Controlling authority under whom their Service Book is maintained at SSA/Circle level. Data is also required to be verified by the SSAs in SAP/ERP.**

8. Applications will be considered only in the stipulated period mentioned above i.e. from **15/07/2019 to 14/08/2019 (to be done at SSA/Circle)**. Candidates will have to provide valid details as per **Annexure-D**.

9. There shall be registration fee for aforesaid LICE of Rs. 500/- for Gen/OBC candidate and Rs. 250/- for SC/ST candidate, paid by candidate through Demand Draft or online mode of payment In favour of AO cash BSNL of the SSA/Circle.

10. Application forms (**Annexure-D**) complete in every respect must be submitted on or before 14-08-2019; after this no application will be accepted..

11. The applicants would be admitted to the examination on the basis of the information furnished by them in their registration form. All the candidates are, therefore, advised to ensure the fulfillment of all eligibility conditions before applying. In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfill any of the eligibility conditions, the candidature of such applicants would be cancelled even if the candidate qualifies in the LICE and no correspondence in this regard would be entertained. Issuance of Admit card for the examination will NOT confer any right for promotion or otherwise. Promotion will be solely provisional subject to the fulfillment of all eligibility conditions/vacancy/merit.

12. No electronic gadget or mobile phone etc. will be permitted to be taken inside the examination premises by the candidates.

SSAs will arrange demo class at the SSA level to familiarize the aspiring candidates for appearing in LICE. The demo class at SSA level may be imparted by Recruitment Cell of each SSA.

Applicants have option either to apply on-line or submit the filled in application directly to the concerned SSA. Applications received directly by hand may also be filled on-line by the concerned SSA. After scrutiny of applications as per Recruitments Rules of TM 2012 and as per the instructions issued from time to time, the application should also be verified, recommended/not recommended on-line by the concerned SSA on or before 17/08/2019.

Candidates from the SSAs where vacancy is available can only apply. SSAs are requested to call for applications among the eligible officials under their jurisdiction as per the instructions in this notification. All the details in the application may please be scrutinized as per the official records.

After scrutiny, list of eligible SC, ST and Minority candidates may be sent to AGM(HRD) , Circle Office, Bangalore on or before 18-08-2019, for arrangement of preexam training.

- (c) Examination form will appear and the applicant should fill columns in the form.
- (d) Applicants belonging to the Attached units are required to submit to their parent SSA.
- (e) After filling up all the details, application form may be submitted by selecting the option "SUBMIT" and the applicants should take the print out of the same & submit it to the concerned.
